## MEETING MINUTES Thursday, February 16, 2023, 7:30PM

2. Recognition of Visitors: Chairman Miner recognized Geoff McLean, Last Green Valley, Nicole Haggerty, Town Planner, Irene Mihok, Anne Staebner, Tom Miner, Alden Miner, and Heather Glidden

Mr. McLean provided a presentation and touched on the following topics:

- Fully shielded LED lights on highways helped reduce light pollution, no light above the 90-degree angle. Replace light fixtures that send light upwards into the sky. Install outdoor lighting only where it is needed, to reduce light pollution.
- > Many animals require true dark night time conditions for successful hunting.
- > Light pollution at night prevents being able to see the stars and Milky Way Galaxy.
- > Outdoor lighting should enhance visibility, not produce glare, not allow light to cross other people's property.
- > Unshielded lighting is a waste of energy, light up unnecessary areas and have higher costs.
- > Use recessed fittings, buried fittings, shielded etc.
- > LED lighting can cover roughly four times the mounting height. 50ft pole can light approx. 40,000 sqft.
- External lighting used to light external signage. Not using interior lighting to light exterior sign, I.E. Home Depot/McDonalds signs.
- Motion censored security lighting.
- > Dark Sky approved lighting, Lowes has good selection of dark sky lighting fixtures.
