## d. Monthly Selectman's Report:

- ➤ Fire Department: There was discussion about Fire Department funding in terms of income and expenses. It was clarified the Fire Department is not a Town entity and is privately owned and operated; and, therefore do not provide financial reports to BOF. However, there is some financial overlap in such that the Town providing funds to purchase fire trucks while the Fire Department owns and operates the ambulance. Additionally, the Town does funds for some first aid supplies and some equipment.
- > Public Works: Vehicle maintenance and replacement part for older vehicles is ongoing as expected.
- ➤ Tree Removal: Eversource will be in town in March and Asplund Tree Service has been in Giddings marking needed locations for tree removal. More trees may be coming down in town in preparation Fiber Optic Line installation.
- > Water / Sewer: Discussion took place about current bonding balance to be paid by residents and current income from connections.
- > Sand / Salt: Due to a mild winter sand & salt supplies are in good shape
