INCOME: State Education Support funds have not been received. Expecting 25% to come in soon.

EXPENSE: There was discussion about First Selectman Health Insurance costs and itemization of chosen coverage.

There was review of various line items, including but not limited to, salary of aides, un-employment costs, legal fees (300% over), and capital outlay costs (current \$54,000 spent with \$30,000 budgeted). It was noted, these line items are continuously going over budget by a considerable amount. BOF would like an explanation of why this continues to happen.

BOF would like BOE to answer the question of why above noted line items are considerably high considering the Town is only ½ way through the year.

BOF would like BOE to answer the question of why the Special Education Director's salary is approximately \$60,000 a year and BOE continues to pay a lawyer to manage special education issues at a considerable cost to residents.

d. Monthly Selectman's Report:

WINTER PREPARATIONS: This season is proving challenging due to large amounts of snow and the timing of storms. Salt has been purchased and stocked. Trucks have needed maintenance, been repaired, and are ready to go.

FRANKLIN ELEMENTARY AIR QUALITY: The Town continues to work with Green Valley School on resolving Franklin Elementary School Air Quality. Issues with the mechanical rooms and de-humidifying are being worked out and there may be improvements to parts of the building to reduce moisture.
