  - a. Monthly Tax Collection Report: Kelsey Allard reviewed the Tax Collector's report.
    - ➤ 98.12% of taxes collected on the 2017 Grand List
    - > \$81,855.51 prior years taxes collected
    - > \$43,528.77 interest and lien fees collected
  - b. **Monthly Board of Selectmen Income Report**: Mr. Grant reviewed the report as submitted. Overall, budget line items are where they should be. Mr. Grant noted the State has issued Educational Cost Sharing and Town Aid Road funds to the town.
  - c. **Monthly Board of Selectmen Expense Report**: Mr. Grant reviewed his report as submitted. Budget is where it should be for this time of year.
  - d. **Monthly Board of Education Report**: Mr. Calvert projected the BOE Budget will be in the black this fiscal year. BOF asked Mr. Calvert to provide more information on various salary items, service contracts, and heat & energy line items that went over budget this year for the next BOF meeting.
  - e. Monthly Selectman's Report: All things are where they should be.

- 7. Old Business:
  - a. Discussion and Action Proposed FY 2019-2020 Board of Selectmen & Board of Education Budgets:

BOF MN: 05-14-19 2

**Board of Selectmen**: Charlie Grant presented the Proposed FY 2019-2020 Municipal Budget. He asked the BOF to allow the following changes to the income side of the budget:

- 1. Increase Line item 4000.00, Interest Income, from \$10,000 to \$40,000
- 2. Increase Line Item 6000.05, Educational Cost Sharing, from \$653,699 to \$784,087

**MOTION #2 (05.14.19):** made by Calli Carboni SECONDED BY Susan Dombrowski that the Board of Finance accepts the Board of Selectman's Budget as amended and moves it to Public Hearing

## Discussion ensued:

Expenses remain at \$2,763,741 Income increased to \$7,116,454 Chairman Handfield noted the proposed Municipal Budget represents a 4% increase

**VOICE VOTE: UNANIMOUS;**

**Board of Education**: Mr. Calvert presented the Board of Education Budget and noted there will be a 0% proposed increase. Charlie Grant noted the BOF allocated \$829,080 to the BOE for FY 2018-2019. The State has reduced ECS to \$784.087 for FY 2019-2010 — a difference of \$44,993. The BOF discussed reducing the BOE FY2019-2020 budget by that amount as an off-set. It was noted, the BOF is responsible for appropriating a specified amount of funds to the BOE from the Town Municipal Budget. The BOE is then responsible for managing such funds in a fiscally responsible manner as applied to educational programming services. The BOE has stayed within their appropriated amount for FY 2018-2019. The BOE experiences unknown expenses, such as special education costs, just as the Town may experience unknown income and/or expenses. This isn't something we should hold against the BOE and this should be considered prior to acting on a reduction of the BOE budget amount.
