There response time might be better. Uncas seems to be more expensive but they seem to be very responsive. Selectman Charles Grant suggested we call other towns and speck to their first selectmen to get their inputs on their public health district. First Selectman Richard matters will call other towns and get more information on their services with their public health districts.
- b. **Discussion on Consulting:** First Selectman Richard Matters explained that he would consider helping Charles Grant transition into the new first selectman position in the next year. He explained that there is a lot to this job and he would like to help the town out especially for the sewer project. I will be here for guidance if needed.
