MOTION #1: Selectman Thomas Craney made motion to accept the minutes as amended. Selectman Russell Beisiegel seconded the motion.

REVIEW OF REPORTS:

A. Department of Public Works:

- a large cardboard dumpster will be delivered to the Town's transfer station this week for town residents use during day with the same hours as the brush dumpster.
- -staff has been sweeping and replaced the bumper of a truck involved in a recent accident.
- -Labor contract negotiations will take place the first week of April.

B. Financial Reports: Up to date financial reports were presented and a discussion was had. The Assessor has completed the new grand list; it has decreased. It has been questioned why the town pays the First Selectman for insurance; the payment is taking lieu of the town's insurance.

- **A. Murphy Road Widening:** Matt Maynard presented an overview of the Murphy Road Widening project. Once the CT DOT files the deed for the easement the Town can then apply for the encroachment permit for the tree at the route 87 end of the road. It was suggested that Matt adds some retainage to the bid. A discussion of specifics of the project were discussed. Bids will be due before the May 12th Board of Selectman meeting.
- B. 2021-2022 Budget Requests: Line items were reviewed and discussions was had. Modifications were made was needed.

PUBLIC COMMENTS: COVID-19: town positivity rate has continued to stay low. Steps for the senior center to open will begin. Charles will look into the capacity limit and spacing for tables. ECTC reports they can transport residents safely and is willing to make two trips if needed. The idea of possibility of requiring preregistration was discussed. Library and the Town Hall protocol will remain the same. Memorial Day festivities will be discussed at the next meeting.
