**204 ROUTE 32:** Concerns with this property continue. Telephone poles may have been pushed down the embankment towards existing pond. Discussion took place on history of violations on this property.

It was noted 1) IWWC has not lifted current cease and desist order to keep telephone poles out of wetlands; and, 2) IWWC did approve site plan compliance to seed and stabilize area in and around wetlands.
