  - a. **IWWC # 19-02 David Lunt:** Jurisdictional Ruling for installation of an in-ground swimming pool; activity is within 50 ft' of the upland review area; property located at 475 Pond Rd., GIS Map 12, Lot 39, Zoned R-80; existing use of property is residential and is in the R-80 Zone.

**APPLICANT PRESENTATION**: David Lunt provided a map of the property and gave a brief overview of proposed activities.

**IWWC COMMENTS**: IWWC held discussions about the exact location of the wetlands upland review area, areas of disturbance, and existing soil conditions in the surrounding area. IWWC recommended locations for the pool and stockpiles of materials. IWWC indicated there is a need for erosion and sedimentation controls.

**MOTION #4 (08.06.19):** made by Mr. Baribeault SECONDED BY Mr. Coleman that the Inland Wetlands and Watercourses Commission approve IWWC # 19-02 David Lunt for installation of an in-ground swimming pool with the following conditions:

- 1. Silt Fence for erosion & sedimentation control must be installed at all borders of the upland review area where construction will take place
- 2. Any area that is disturbed in the upland review area must be re-seeded & mulched to promote re-stabilization of such area.
- 3. Stockpile locations will take place outside upland review area

#### a. FRANKLIN HILLS ESTATES & COUNTRY CLUB:

Carly Myers provided a brief update on the Franklin Hills Golf Course Project. At this time, CLA Engineers, Franklin Consulting Engineers have completed their final review of the plan set including revised plans as a result of the conditions of approval assigned by IWWC on May 29, 2019. CLA has concluded the applicant has met all of their concerns. At this time, the Town Planner and Zoning Enforcement Officer are continuing their review of the plan set as well as administrative and regulatory approvals specified within the Conditions of Approval.

The cost to review, evaluate, and process this application has exceeded application fees paid by the applicant at the time of filing. Currently, there is one outstanding invoice that has been sent to the applicant. Also, there will be an additional invoice for the applicant for the most recent services provided by CLA.
