#### 8. New Business:

a. **Application #17-03 Seymour Adelman**: Proposed Revised Site Plan Review for Regulated Activities, property located on Route 87, Assessor's Map 44, Lot 36, Zoned C-2, existing use is raw land with corn field, proposed use is to construct pond

**APPLICANT / PRESENTATION**: The property as noted in the Application is now owned by Mr. Seymour Adelman. While the property was previously owned by Hugh Schnip, there was an application approved by IWWC that included construction of a pond. However, due to new ownership and modifications to the location of the pond, a new application was required to be filed by Mr. Adelman.

**POND**: Proposed location of the pond has been moved away from wetlands and the local brook while the size of the pond remains the same. The location is not within wetlands but is considered to be in a flood zone. Current use of property is a corn field.

**SITE ACTIVITY:** It was noted the creation of a pond on this property and in the proposed location is a favorable use of the property. It is anticipated activities will begin in the spring.
