IWWC 21-08 GARRETT HOMES LLC: New Site Plan Review for Regulated Activities; Property located at 99 Route 32, Assessors Map 44, Lot 24; Zoned C2/I; Existing use of property is residential, proposed activity includes demolition of existing single-family home & construction of 9,100 s.f. retail store with new paved parking & loading areas, site lighting, concrete walkways, stormwater management system & associated utilities & landscaping.

APPLICANT / PRESENTATION: Mr. Matthew Bruton, Project Engineer for BL Companies was present and submitted/reviewed modified site plans, dated January 4, 2022. He reviewed BL Companies Response letter dated, January 4, 2022, to Towne Engineering's Project Review Letter, dated December 29, 2021. Items 1 through 13 were discussed and addressed. It was noted the State Department of Transportation (DOT) requires a 10-year storm event storm water management analysis. BL Companies has designed the system as required and provided it to DOT. Also, final plans & specifications regarding the retaining wall will be provided by the manufacturer prior to construction. We believe the current design provided by BL Companies is adequate with the wall at 13 feet. Additionally, there was discussion on the improved process for both product loading/unloading and trash/recyclable systems used when going into and out of the building.

TOWNE ENGINEERING COMMENTS: Matt Maynard was present and noted Towne Engineering has just received BL Companies Response letter dated, January 4, 2022, this afternoon. Additional time is needed to review such responses. Incidentally, Mr. Maynard noted most recent site plans have improved since the last revision and the retaining wall remains a concern.

TOWN PLANNER: Carly Holzschuh noted she also received BL Companies Response letter dated, January 4, 2022, this afternoon and would need additional time to review. Additionally, she required the applicant to provide information on the complete review of the drainage system from the Department of Transportation Representative Norm Miller.
