GARRETT HOMES / DOLLAR GENERAL APPLICATION: Garrett Homes / Dollar General Construction Team contacted Mr. Chalecki indicating they are ready to commence construction. Meetings will begin with Town Staff, Contractors, and Developers. Conditions of Approval to be discussed.

204 ROUTE 32 CHIRS SULLIVAN: An excavator near the pond was recently seen on this property. Due to past activities with property owner. This is concerning because Mr. Chalecki noted poles have been slowly dis-appearing. IWWC has been dealing with telephone poles and materials on this property in proximity of the pond as well as in upland review area. CL&P and DEEP have enforcement issues associated to telephone poles on this property.
