- Minutes from the December 7, 2022 Meeting were distributed. Lee J motioned to accept the Minutes as presented. This was seconded by Kyle G and passed unanimously.
- Financial Report as of 11/29/22,

    - None discussed
  - New Business
    - Scott D reported that he had talked to some people using a local Disc Golf course. They referred hi to Jeff Blayman who is associated with the Skate shop in Greenville. Jeff referred him to Shawn who has designed a number of local courses. Jeff also offered to assist with equipment purchases as he has relationships with equipment manufacturers/distributors.
    - o Rich H presented a letter requesting use of the Park facilities for the CT Bombers which was accompanied by a COI naming the Town of Franklin and its Boards and Commissions as additionally insured. Lee J motioned to approve the usage/ The Motion was seconded by Kyle G and passed unanimously without further discussion.
    - O A discussion was held regarding a possible FES Team for both Baseball & Softball. It appeared that it was too late for this season but there is also a concern regarding an acceptable Baseball field. Ideally a 50/70 field would be used/ We have a 43/60 and a 60/90. The first is too small for the 8<sup>th</sup> graders, the second too big for the 5<sup>th</sup> 7<sup>th</sup> graders. This reopened the discussion on trying to get CIP funds to strip the infield of the SLBB (60/90) field to be able to install base pegs for 60, 65, 70, & 90' bases which would allow LLBB, all ages/divisions of Softball (including adult), intermediate/Junior League/ or Middle School Baseball, and Senior League baseball all to utilize the same field using portable mounds (6" for LL, 12" for other Baseball) and temporary pitchers plates for all softball regardless of pitching distance.
    - Next was a discussion of the possible usage of James Khan Field for T-Ball and 9/10 practices at the very least. It was agreed that for those purposes it would be available in the spring. Rich H stated when he does the annual spring clean-up and preparation of the Softball field and track, he would do what could be done for this field as well. That would include using a brush hog to get the briars that have encroached onto the team benches knocked down and chewed up or dragged away.
