**THE MINUTES OF THE REGULAR MEETING OF THE FRANKLIN BOARD OF SELECTMEN HELD AT THE  
TOWN HALL AT 7:00 P.M.  
WEDNESDAY, THE 31<sup>ST</sup> DAY OF OCTOBER, 2018**

**CALL TO ORDER:** First Selectman Charles Grant called the meeting to order at 7:00 p.m.

**PRESENT:** Selectman Russell Beisiegel and Selectman Thomas Craney.

**ADDITIONS TO THE AGENDA:** First Selectman Charles Grant made a request to add the following under New Business:

**MOTION #1:** Selectman Russell Beisiegel made a motion to approve the additions to the agenda as presented. Selectman Thomas Craney seconded the motion. Motion carried unanimously.

- a. **Department of Public Works:**

Road which also took down a powerline. The public works crew have been mowing and cleaning any brush on the roads. First Selectman Charles Grant stated that he has taken pictures of the towns mason dump truck and will soon put it up on Craigslist to sell it. First Selectman Charles Grant will keep the Board of Selectman updated with any new changes.

**b. Financial Report:**

First Selectman Charles Grant gave an update on the town's financial reports. The Board of Selectman briefly went over the updated budget for this fiscal year (2018-2019). The Board of Selectman made a list of a few line items that needed to be revised and corrected. First Selectman Charles Grant will bring an updated copy of the budget to the next meeting.

**MOTION #4:** Selectman Thomas Craney made a motion to approve the DOT State Highway Application for the annual Thanksgiving Turkey Trot. Selectman Russel Beisiegel seconded the motion. Motion carried unanimously.

- d. Discussion on Cross Walk Signage at School:** Selectman Thomas Craney stated that Franklin Elementary School is the one school that does not have a road sign that says "school zone." Selectman Thomas Craney would like to ask the state why is Franklin Elementary the only school without a school zone sign. First Selectman Charles Grant will draft a letter to the state and bring it to the next Board of Selectman meeting for approval.
