go out to bid in August. Selectman Thomas Craney asked "as far as the plan goes does OPM have a problem with the sewer and water project?" First Selectman Charles Grant stated that their concern is the agricultural impact of the town. First selectman Charles Grant will update the Board of Selectman with any new changes at the next meeting.
